





The relative strengths and weaknesses of Nibelungen Wohnbau GmbH Braunschweig are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Nibelungen Wohnbau GmbH Braunschweig compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 63% points. The greatest weakness of Nibelungen Wohnbau GmbH Braunschweig is the variable Operating Result Tc, reducing the Economic Capital Ratio by 287% points.

The company's Economic Capital Ratio, given in the ranking table, is 63%, being 34% points below the market average of 97%.
