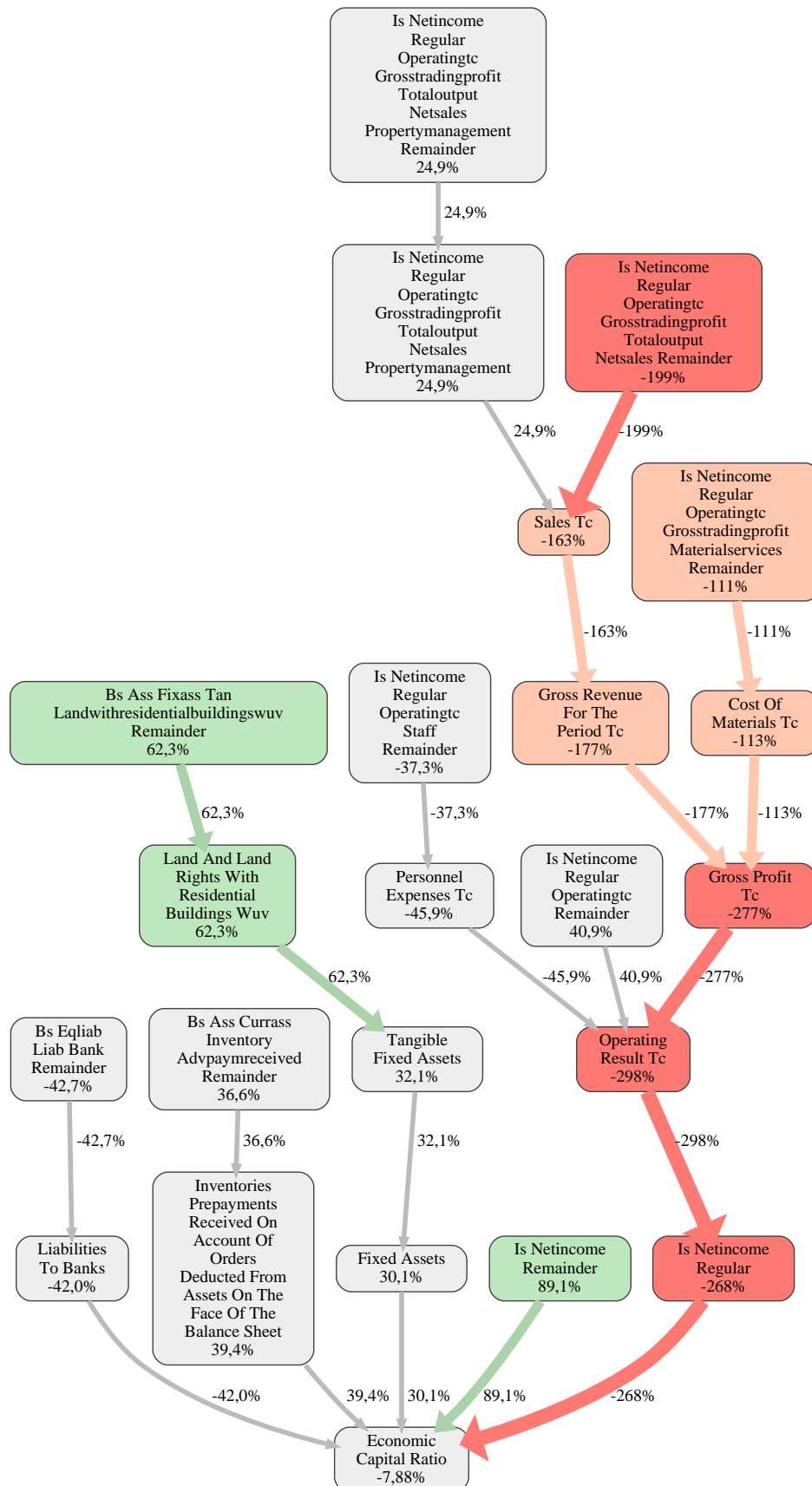

The relative strengths and weaknesses of Wohnungsbaugesellschaft mit Beschränkter Haftung Salzgitter are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft mit Beschränkter Haftung Salzgitter compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 89% points. The greatest weakness of Wohnungsbaugesellschaft mit Beschränkter Haftung Salzgitter is the variable Operating Result Tc, reducing the Economic Capital Ratio by 298% points.

The company's Economic Capital Ratio, given in the ranking table, is 89%, being 7,9% points below the market average of 97%.
