



The relative strengths and weaknesses of Auer Wohnungsbaugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Auer Wohnungsbaugesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 143% points. The greatest weakness of Auer Wohnungsbaugesellschaft mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 318% points.

The company's Economic Capital Ratio, given in the ranking table, is 144%, being 47% points above the market average of 97%.
