



The relative strengths and weaknesses of Gebäude und Grundstücksgesellschaft Zwickau mbH GGZ are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gebäude und Grundstücksgesellschaft Zwickau mbH GGZ compared to the market average is the variable Bs Ass Fixass Tan Remainder, increasing the Economic Capital Ratio by 122% points. The greatest weakness of Gebäude und Grundstücksgesellschaft Zwickau mbH GGZ is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 242% points.

The company's Economic Capital Ratio, given in the ranking table, is 128%, being 31% points above the market average of 97%.
