The greatest strength of Wohnungsbaugesellschaft der Stadt Langenzenn Gesellschaft mit Beschränkter Haftung GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 99% points. The greatest weakness of Wohnungsbaugesellschaft der Stadt Langenzenn Gesellschaft mit Beschränkter Haftung GmbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 311% points.

The company's Economic Capital Ratio, given in the ranking table, is 99%, being 1,6% points above the market average of 97%.
