



The relative strengths and weaknesses of Wohnungsbaugesellschaft mbH Meiningen are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft mbH Meiningen compared to the market average is the variable Inventories Prepayments Received On Account Of Orders Deducted From Assets On The Face Of The Balance Sheet, increasing the Economic Capital Ratio by 0,30% points. The greatest weakness of Wohnungsbaugesellschaft mbH Meiningen is the variable Stockholders Equity, reducing the Economic Capital Ratio by 85% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,30%, being 97% points below the market average of 97%.
