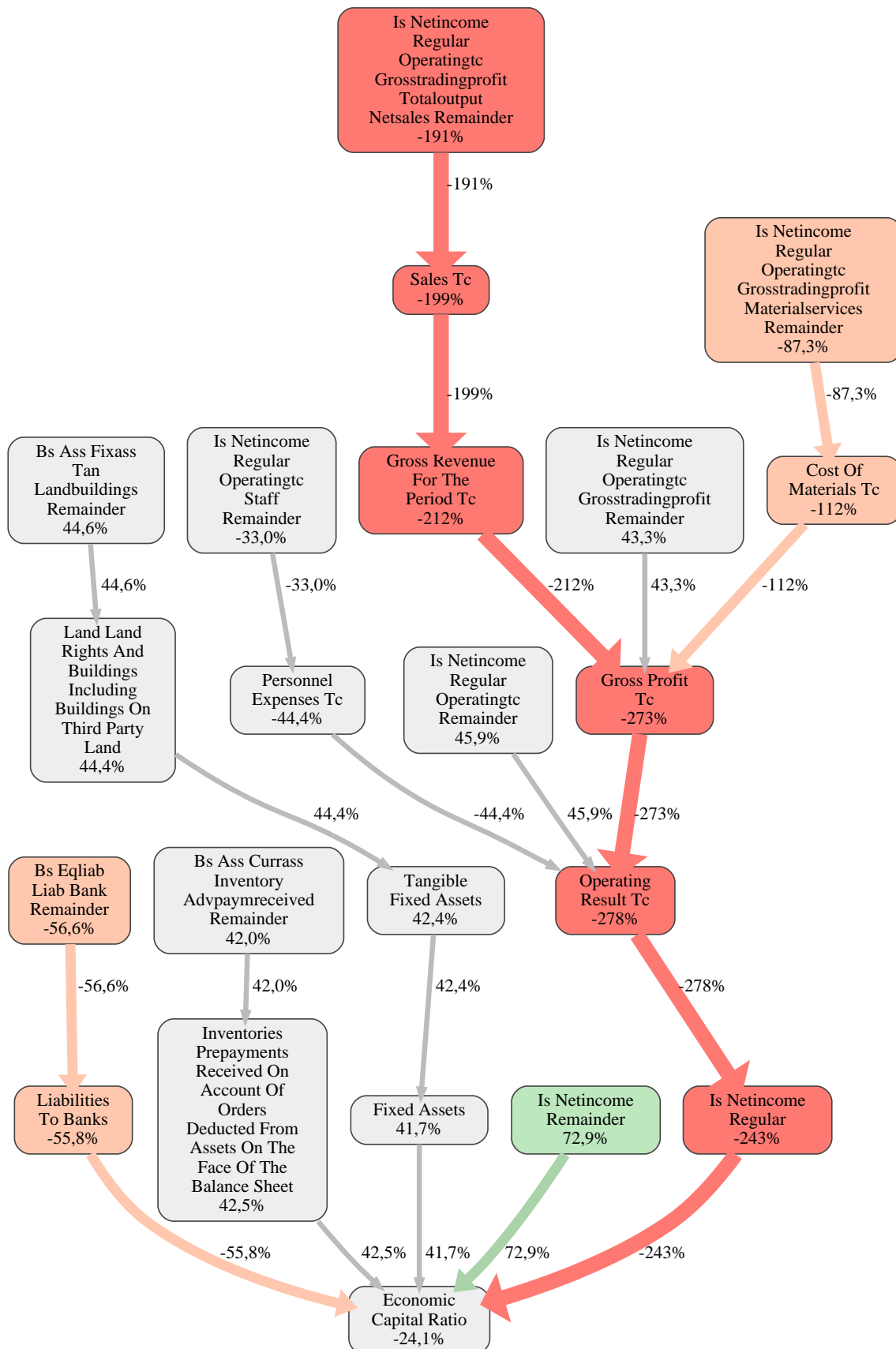

The relative strengths and weaknesses of Wohnungsbau GmbH Worms are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau GmbH Worms compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 73% points. The greatest weakness of Wohnungsbau GmbH Worms is the variable Operating Result Tc, reducing the Economic Capital Ratio by 278% points.

The company's Economic Capital Ratio, given in the ranking table, is 73%, being 24% points below the market average of 97%.
