



The relative strengths and weaknesses of Wohnbauten GmbH Schwedt Oder are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbauten GmbH Schwedt Oder compared to the market average is the variable Inventories Prepayments Received On Account Of Orders Deducted From Assets On The Face Of The Balance Sheet, increasing the Economic Capital Ratio by 2,0% points. The greatest weakness of Wohnbauten GmbH Schwedt Oder is the variable Land Land Rights And Buildings Including Buildings On Third Party Land, reducing the Economic Capital Ratio by 359% points.

The company's Economic Capital Ratio, given in the ranking table, is 2,0%, being 95% points below the market average of 97%.
