



The relative strengths and weaknesses of Osnabrücker Wohnungsbaugesellschaft mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Osnabrücker Wohnungsbaugesellschaft mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 47% points. The greatest weakness of Osnabrücker Wohnungsbaugesellschaft mit Beschränkter Haftung is the variable Operating Result Tc, reducing the Economic Capital Ratio by 231% points.

The company's Economic Capital Ratio, given in the ranking table, is 47%, being 50% points below the market average of 97%.
