The greatest strength of Rostocker Gesellschaft für Stadterneuerung Stadtentwicklung und Wohnungsbau mit Beschränkter Haftung compared to the market average is the variable Is Netincome Regular Operatingtc Remainder, increasing the Economic Capital Ratio by 70% points. The greatest weakness of Rostocker Gesellschaft für Stadterneuerung Stadtentwicklung und Wohnungsbau mit Beschränkter Haftung is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 147% points.

The company's Economic Capital Ratio, given in the ranking table, is 154%, being 57% points above the market average of 97%.
