



The relative strengths and weaknesses of Dogewo Dortmunder Gesellschaft für Wohnen mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dogewo Dortmunder Gesellschaft für Wohnen mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 51% points. The greatest weakness of Dogewo Dortmunder Gesellschaft für Wohnen mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 262% points.

The company's Economic Capital Ratio, given in the ranking table, is 51%, being 46% points below the market average of 97%.
