



The relative strengths and weaknesses of HIW Hoch und Ingenieurbau Wilsdruff GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HIW Hoch und Ingenieurbau Wilsdruff GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 46% points. The greatest weakness of HIW Hoch und Ingenieurbau Wilsdruff GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 1.800% points.

The company's Economic Capital Ratio, given in the ranking table, is 46%, being 51% points below the market average of 97%.
