



The relative strengths and weaknesses of IWS Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of IWS Bau GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 130% points. The greatest weakness of IWS Bau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 284% points.

The company's Economic Capital Ratio, given in the ranking table, is 130%, being 32% points above the market average of 97%.
