

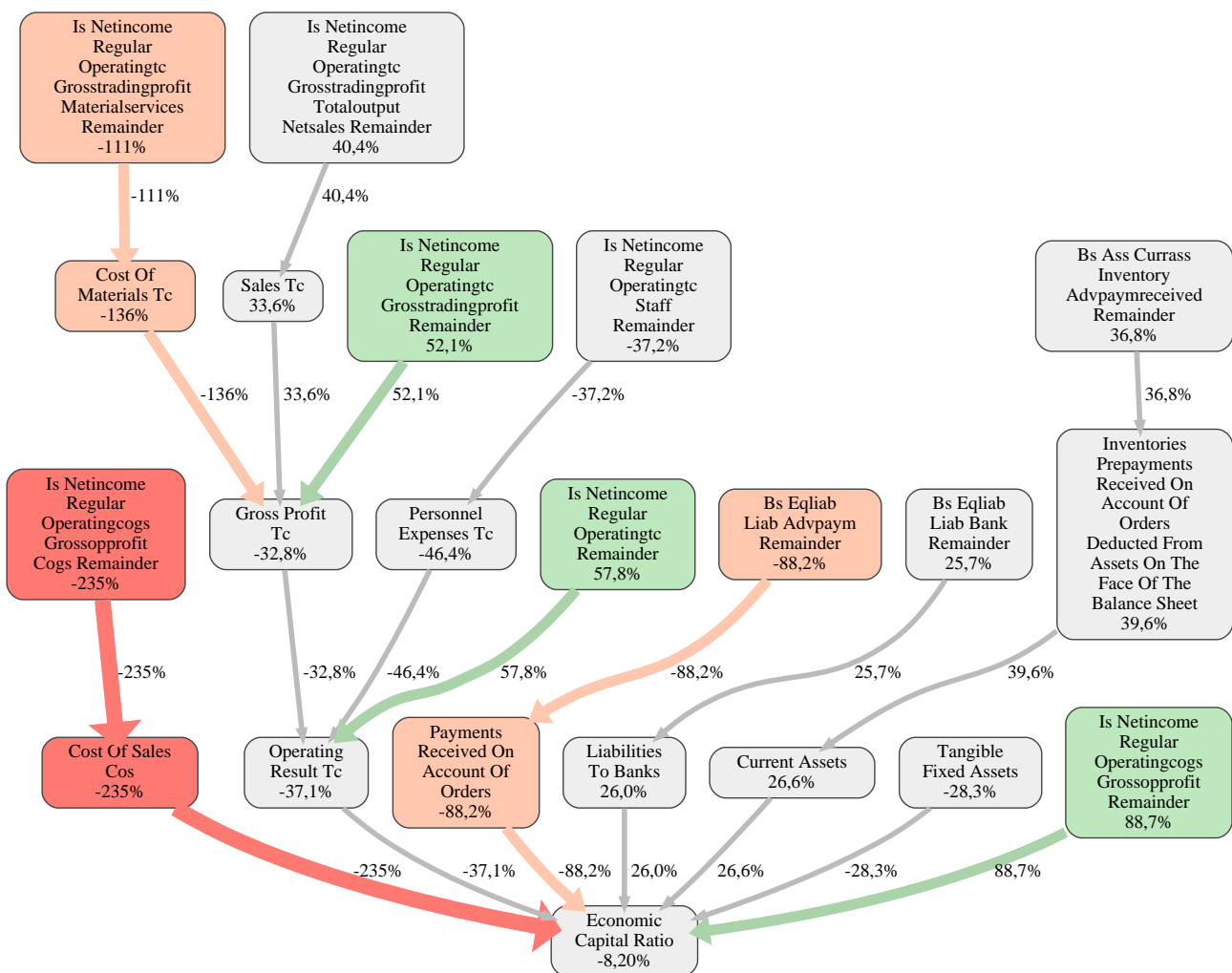

The relative strengths and weaknesses of Takenaka Europe GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Takenaka Europe GmbH compared to the market average is the variable Is Netincome Regular Operatingcogs Grossoprofit Remainder, increasing the Economic Capital Ratio by 89% points. The greatest weakness of Takenaka Europe GmbH is the variable Is Netincome Regular Operatingcogs Grossoprofit Cogs Remainder, reducing the Economic Capital Ratio by 235% points.

The company's Economic Capital Ratio, given in the ranking table, is 89%, being 8,2% points below the market average of 97%.
