



The relative strengths and weaknesses of BB Government Services GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BB Government Services GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 164% points. The greatest weakness of BB Government Services GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 772% points.

The company's Economic Capital Ratio, given in the ranking table, is 164%, being 67% points above the market average of 97%.
