



The relative strengths and weaknesses of HS Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HS Bau GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 53% points. The greatest weakness of HS Bau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 909% points.

The company's Economic Capital Ratio, given in the ranking table, is 53%, being 44% points below the market average of 97%.
