

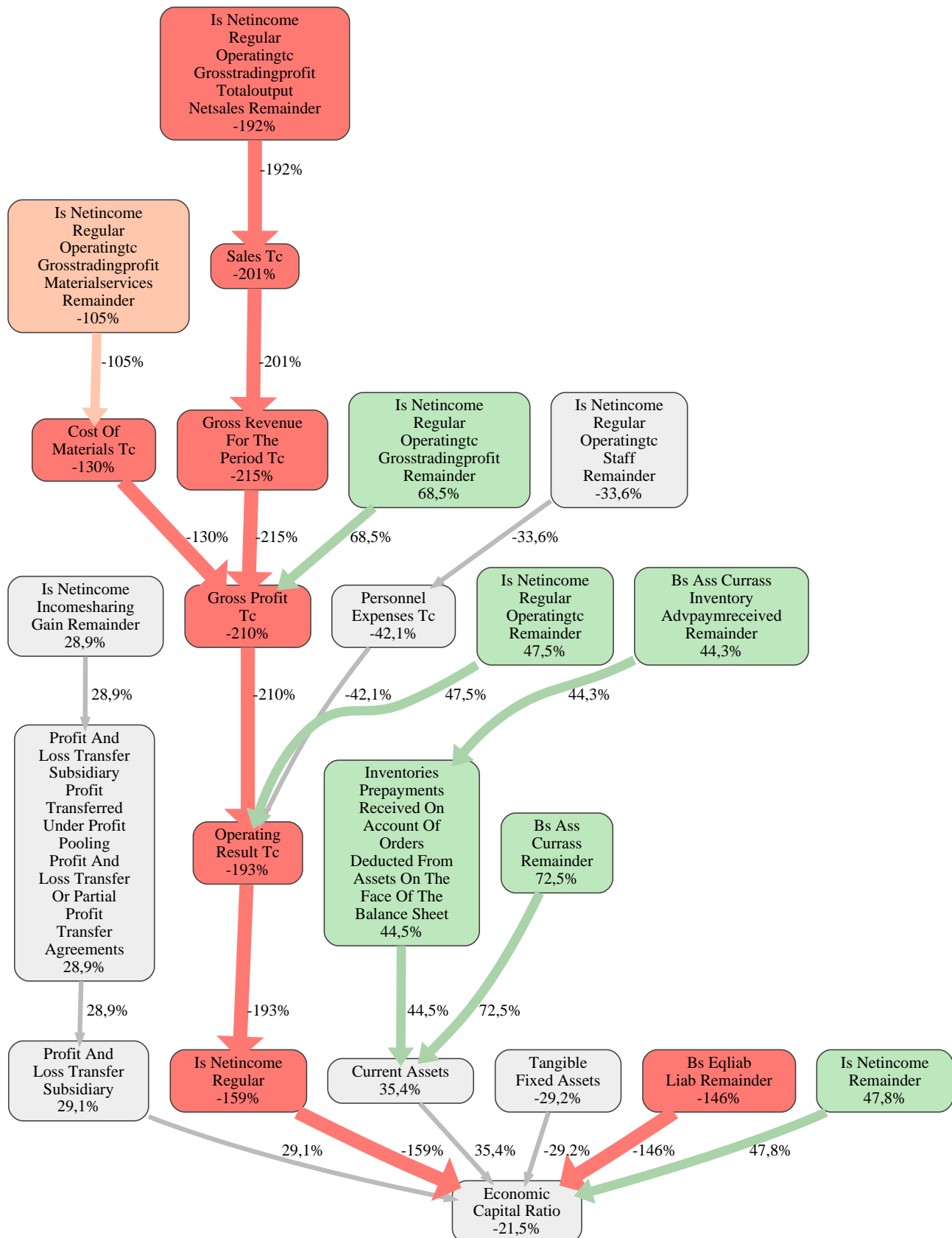

The relative strengths and weaknesses of Heinz Schnorpfeil Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Heinz Schnorpfeil Bau GmbH compared to the market average is the variable Bs Ass Currass Remainder, increasing the Economic Capital Ratio by 73% points. The greatest weakness of Heinz Schnorpfeil Bau GmbH is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 215% points.

The company's Economic Capital Ratio, given in the ranking table, is 75%, being 22% points below the market average of 97%.
