



The relative strengths and weaknesses of Bauunternehmung Glöckle SF Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Glöckle SF Bau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 122% points. The greatest weakness of Bauunternehmung Glöckle SF Bau GmbH is the variable Bs Ass Currass Inventory Remainder, reducing the Economic Capital Ratio by 968% points.

The company's Economic Capital Ratio, given in the ranking table, is 151%, being 54% points above the market average of 97%.
