



The relative strengths and weaknesses of Bremer Leipzig GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bremer Leipzig GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 195% points. The greatest weakness of Bremer Leipzig GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 823% points.

The company's Economic Capital Ratio, given in the ranking table, is 195%, being 98% points above the market average of 97%.
