

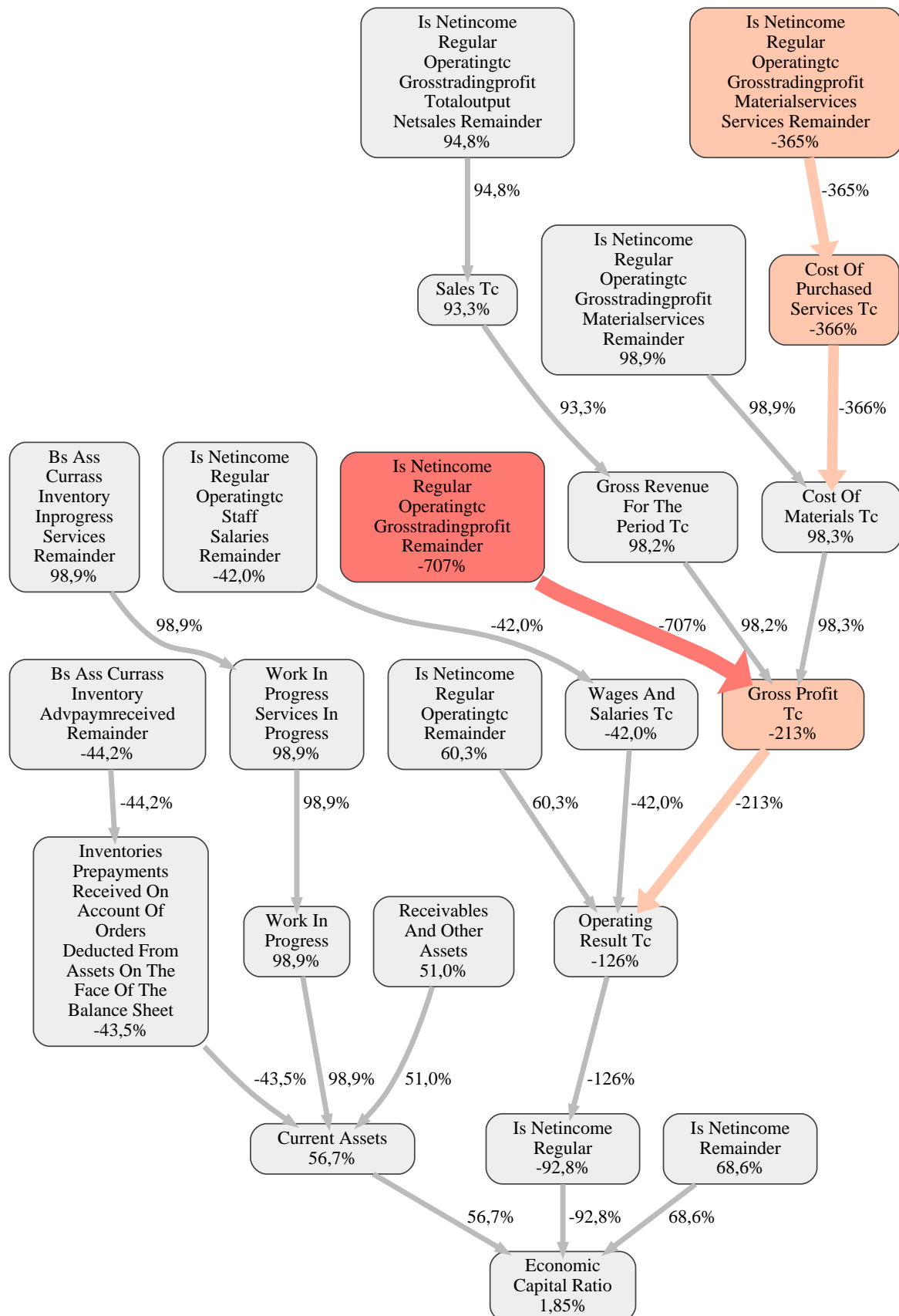

The greatest strength of d & b Bau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 99% points. The greatest weakness of d & b Bau GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 707% points.

The company's Economic Capital Ratio, given in the ranking table, is 99%, being 1,9% points above the market average of 97%.
