



The relative strengths and weaknesses of Hofschröder Projektbau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hofschröder Projektbau GmbH Co KG compared to the market average is the variable Bs Ass Currass Inventory Remainder, increasing the Economic Capital Ratio by 51% points. The greatest weakness of Hofschröder Projektbau GmbH Co KG is the variable Operating Result Tc, reducing the Economic Capital Ratio by 290% points.

The company's Economic Capital Ratio, given in the ranking table, is 51%, being 46% points below the market average of 97%.
