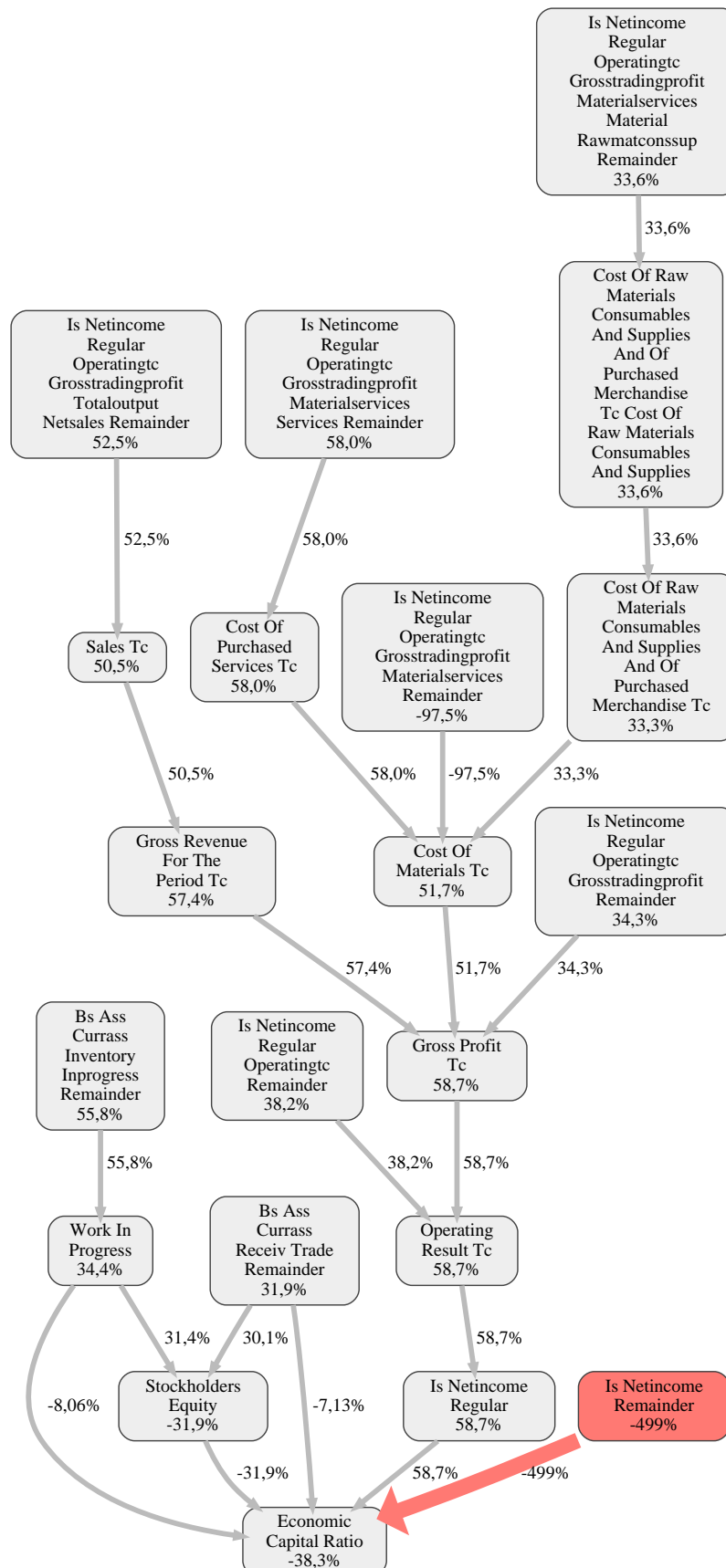

The greatest strength of Mainka Bau GmbH Co KG compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 59% points. The greatest weakness of Mainka Bau GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 499% points.

The company's Economic Capital Ratio, given in the ranking table, is 59%, being 38% points below the market average of 97%.
