

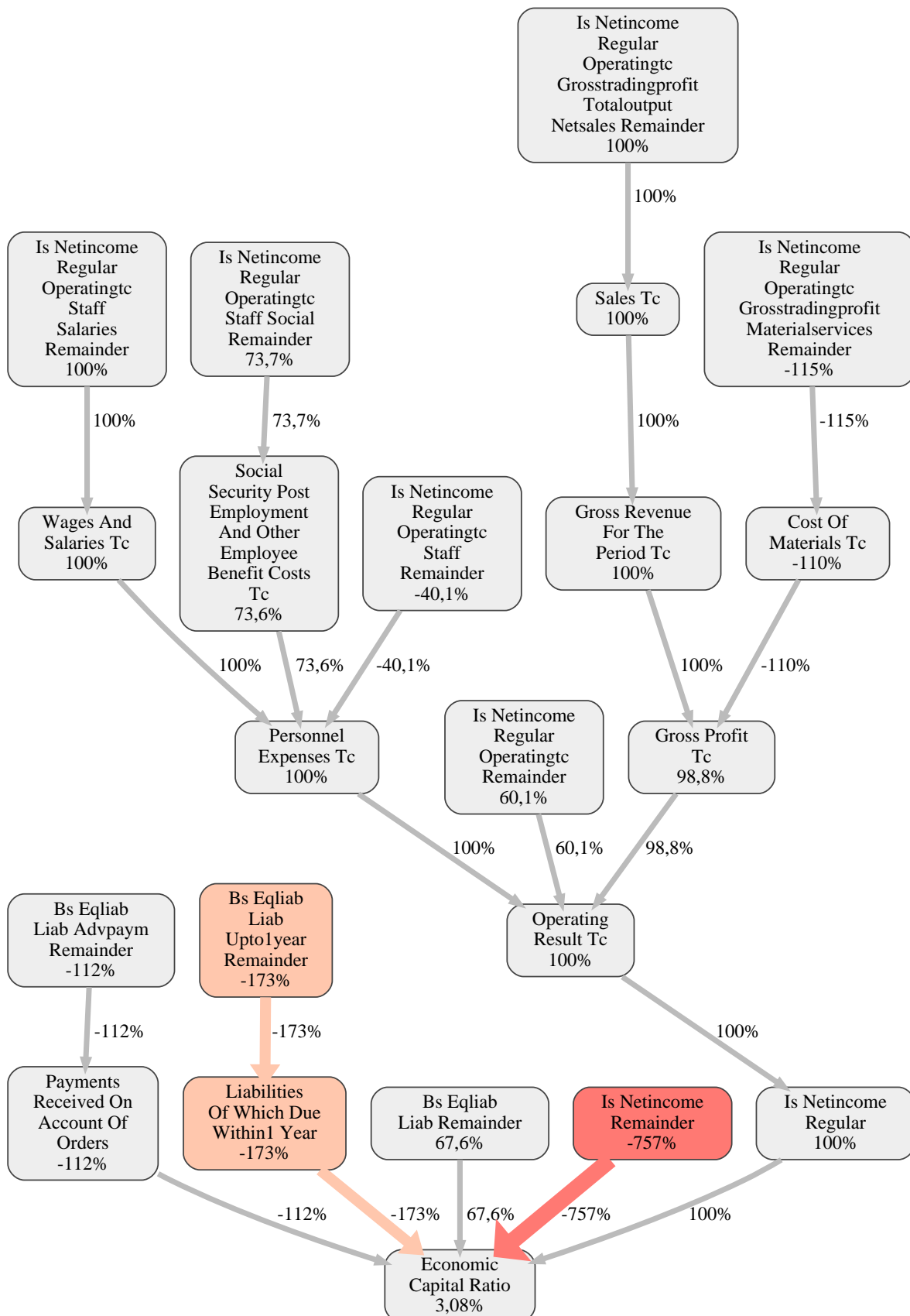

The relative strengths and weaknesses of GD Bau UG Haftungsbeschränkt are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GD Bau UG Haftungsbeschränkt compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 100% points. The greatest weakness of GD Bau UG Haftungsbeschränkt is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 757% points.

The company's Economic Capital Ratio, given in the ranking table, is 100%, being 3,1% points above the market average of 97%.
