



The relative strengths and weaknesses of Josef Meier GmbH Co KG Hoch und Tiefbau are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Meier GmbH Co KG Hoch und Tiefbau compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Josef Meier GmbH Co KG Hoch und Tiefbau is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 173% points.

The company's Economic Capital Ratio, given in the ranking table, is 89%, being 7,5% points below the market average of 97%.
