



The relative strengths and weaknesses of Anton Schick GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Anton Schick GmbH Co KG compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 92% points. The greatest weakness of Anton Schick GmbH Co KG is the variable Work In Progress, reducing the Economic Capital Ratio by 3.958% points.

The company's Economic Capital Ratio, given in the ranking table, is 92%, being 5,5% points below the market average of 97%.
