



The relative strengths and weaknesses of Porr Industriebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Porr Industriebau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 115% points. The greatest weakness of Porr Industriebau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 601% points.

The company's Economic Capital Ratio, given in the ranking table, is 115%, being 18% points above the market average of 97%.
