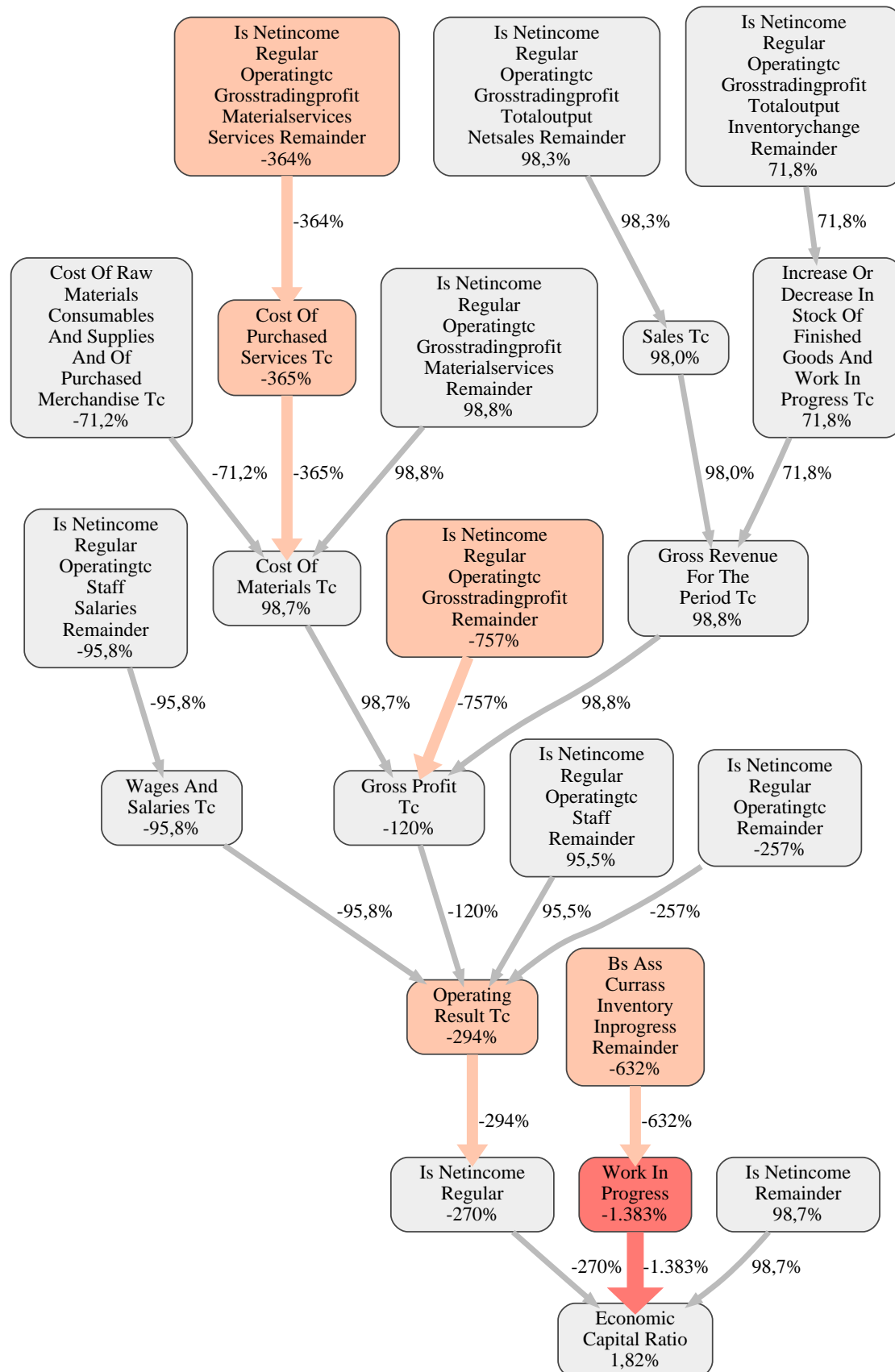

The greatest strength of Echterhoff Holding GmbH Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 99% points. The greatest weakness of Echterhoff Holding GmbH Konzern is the variable Work In Progress, reducing the Economic Capital Ratio by 1.383% points.

The company's Economic Capital Ratio, given in the ranking table, is 99%, being 1,8% points above the market average of 97%.
