The greatest weakness of Pfaffinger Verwaltungs GmbH Konzern is the variable Is Netincome Regular Remainder, reducing the Economic Capital Ratio by 7.899% points.

The company's Economic Capital Ratio, given in the ranking table, is 0%, being 97% points below the market average of 97%.
