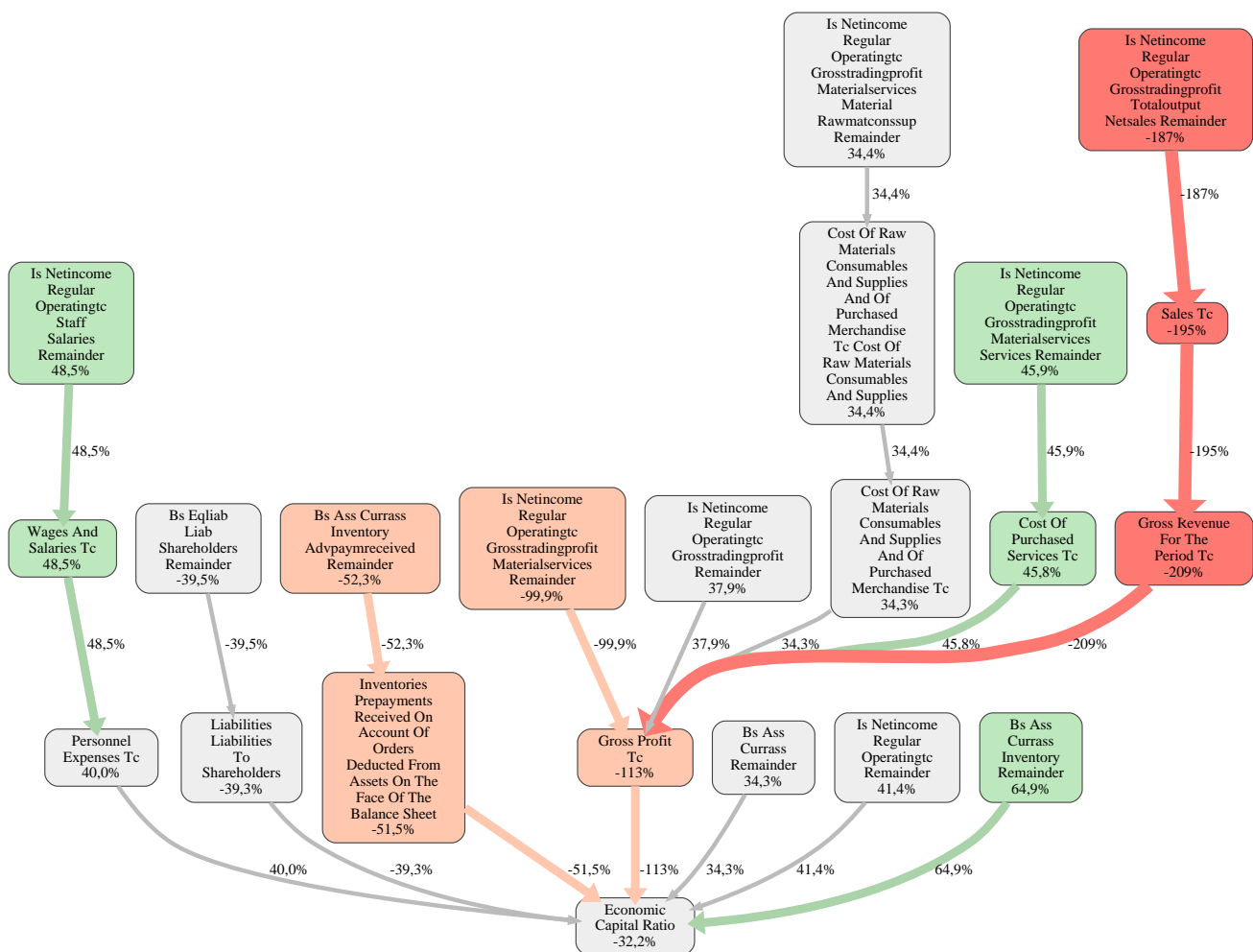

The greatest strength of Anton Meyer GmbH Co KG Konzern compared to the market average is the variable Bs Ass Currass Inventory Remainder, increasing the Economic Capital Ratio by 65% points. The greatest weakness of Anton Meyer GmbH Co KG Konzern is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 209% points.

The company's Economic Capital Ratio, given in the ranking table, is 65%, being 32% points below the market average of 97%.
