The relative strengths and weaknesses of Krämmel Gesellschaft mit Beschränkter Haftung Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Krämmel Gesellschaft mit Beschränkter Haftung Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 137% points. The greatest weakness of Krämmel Gesellschaft mit Beschränkter Haftung Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 414% points.

The company's Economic Capital Ratio, given in the ranking table, is 137%, being 40% points above the market average of 97%.
