



The relative strengths and weaknesses of Gewobag Wohnungsbau Aktiengesellschaft Berlin Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gewobag Wohnungsbau Aktiengesellschaft Berlin Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 40% points. The greatest weakness of Gewobag Wohnungsbau Aktiengesellschaft Berlin Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 266% points.

The company's Economic Capital Ratio, given in the ranking table, is 40%, being 57% points below the market average of 97%.
