



The relative strengths and weaknesses of GWG Städtische Wohnungsgesellschaft München mbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GWG Städtische Wohnungsgesellschaft München mbH Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 106% points. The greatest weakness of GWG Städtische Wohnungsgesellschaft München mbH Konzern is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 290% points.

The company's Economic Capital Ratio, given in the ranking table, is 106%, being 9,2% points above the market average of 97%.
