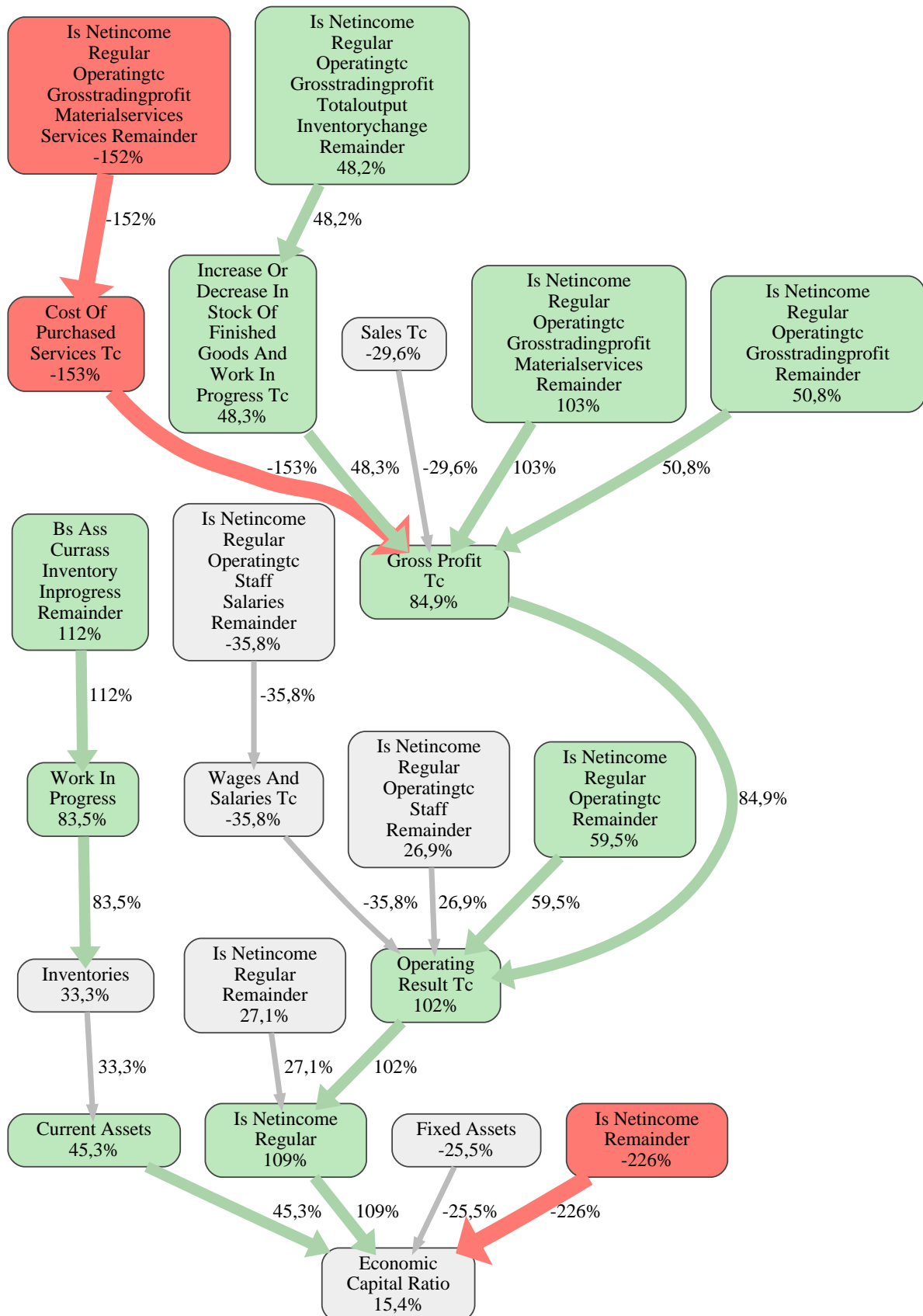

The relative strengths and weaknesses of Otto Wulff Bauunternehmung GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Otto Wulff Bauunternehmung GmbH Konzern compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 112% points. The greatest weakness of Otto Wulff Bauunternehmung GmbH Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 226% points.

The company's Economic Capital Ratio, given in the ranking table, is 112%, being 15% points above the market average of 97%.
