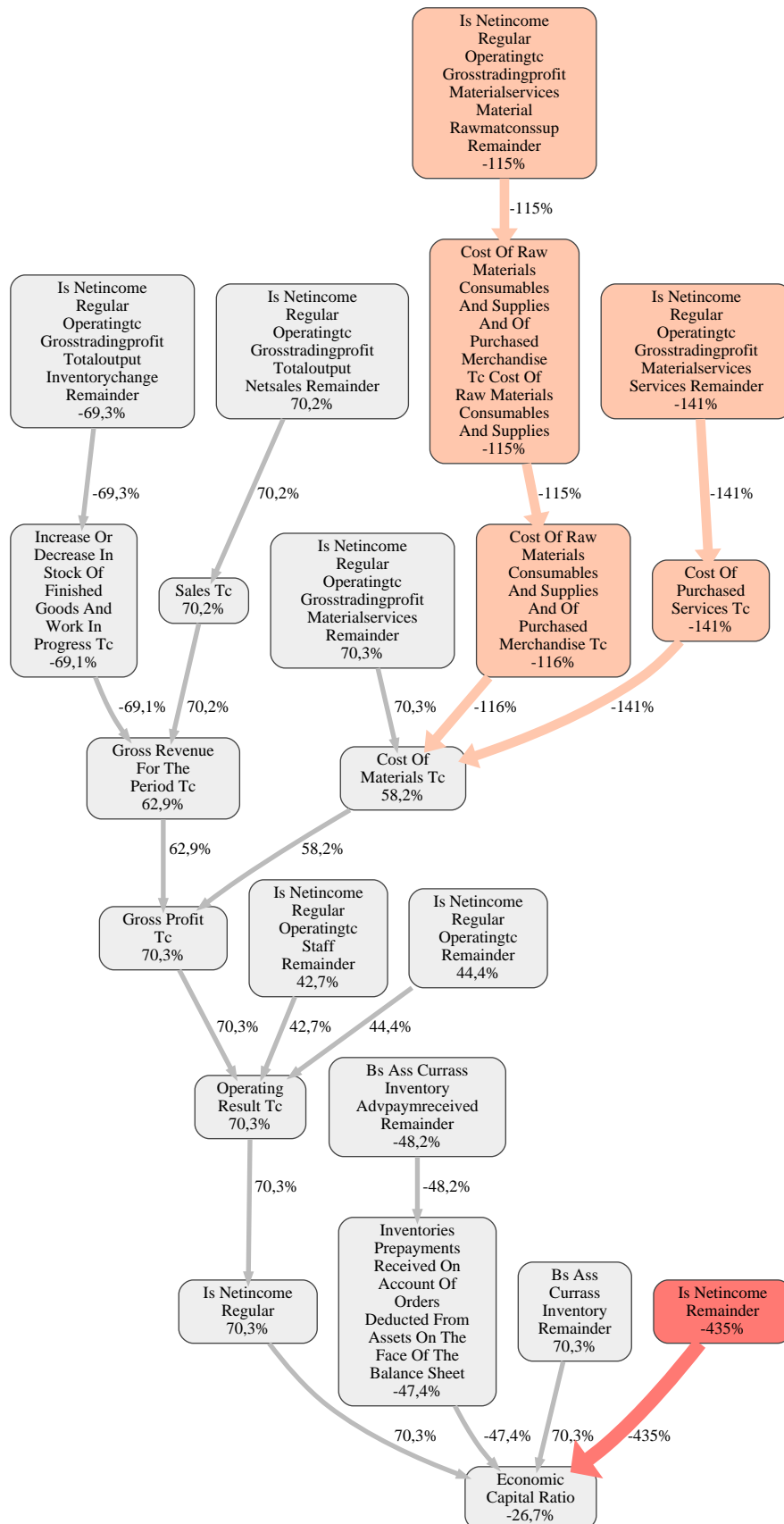

The relative strengths and weaknesses of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG Konzern compared to the market average is the variable Bs Ass Currass Inventory Remainder, increasing the Economic Capital Ratio by 70% points. The greatest weakness of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 435% points.

The company's Economic Capital Ratio, given in the ranking table, is 70%, being 27% points below the market average of 97%.
