The relative strengths and weaknesses of Wohnbauwerk der Gemeinde Ruhpolding Gesellschaft mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbauwerk der Gemeinde Ruhpolding Gesellschaft mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 197% points. The greatest weakness of Wohnbauwerk der Gemeinde Ruhpolding Gesellschaft mit Beschränkter Haftung is the variable Operating Result Tc, reducing the Economic Capital Ratio by 319% points.

The company's Economic Capital Ratio, given in the ranking table, is 207%, being 110% points above the market average of 97%.
