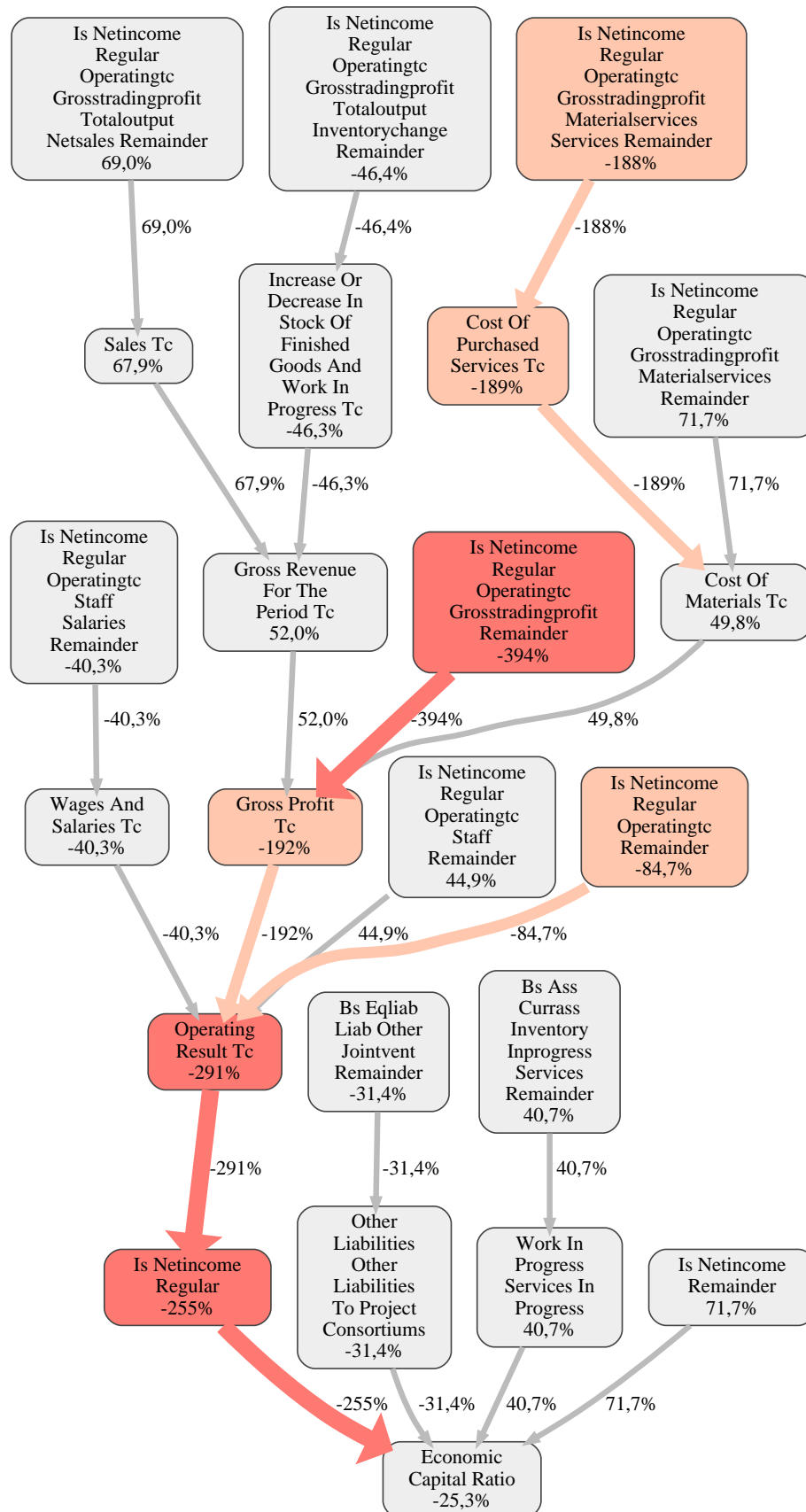

The greatest weakness of Mauss Bau GmbH Co KG Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 394% points.

The company's Economic Capital Ratio, given in the ranking table, is 72%, being 25% points below the market average of 97%.
