



The relative strengths and weaknesses of Pfeiffer GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Pfeiffer GmbH Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 88% points. The greatest weakness of Pfeiffer GmbH Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 481% points.

The company's Economic Capital Ratio, given in the ranking table, is 88%, being 8,5% points below the market average of 97%.
