The greatest strength of Gewobau Erlangen Wohnungsbaugesellschaft der Stadt Erlangen mit Beschränkter Haftung Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 86% points. The greatest weakness of Gewobau Erlangen Wohnungsbaugesellschaft der Stadt Erlangen mit Beschränkter Haftung Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 287% points.

The company's Economic Capital Ratio, given in the ranking table, is 86%, being 11% points below the market average of 97%.
