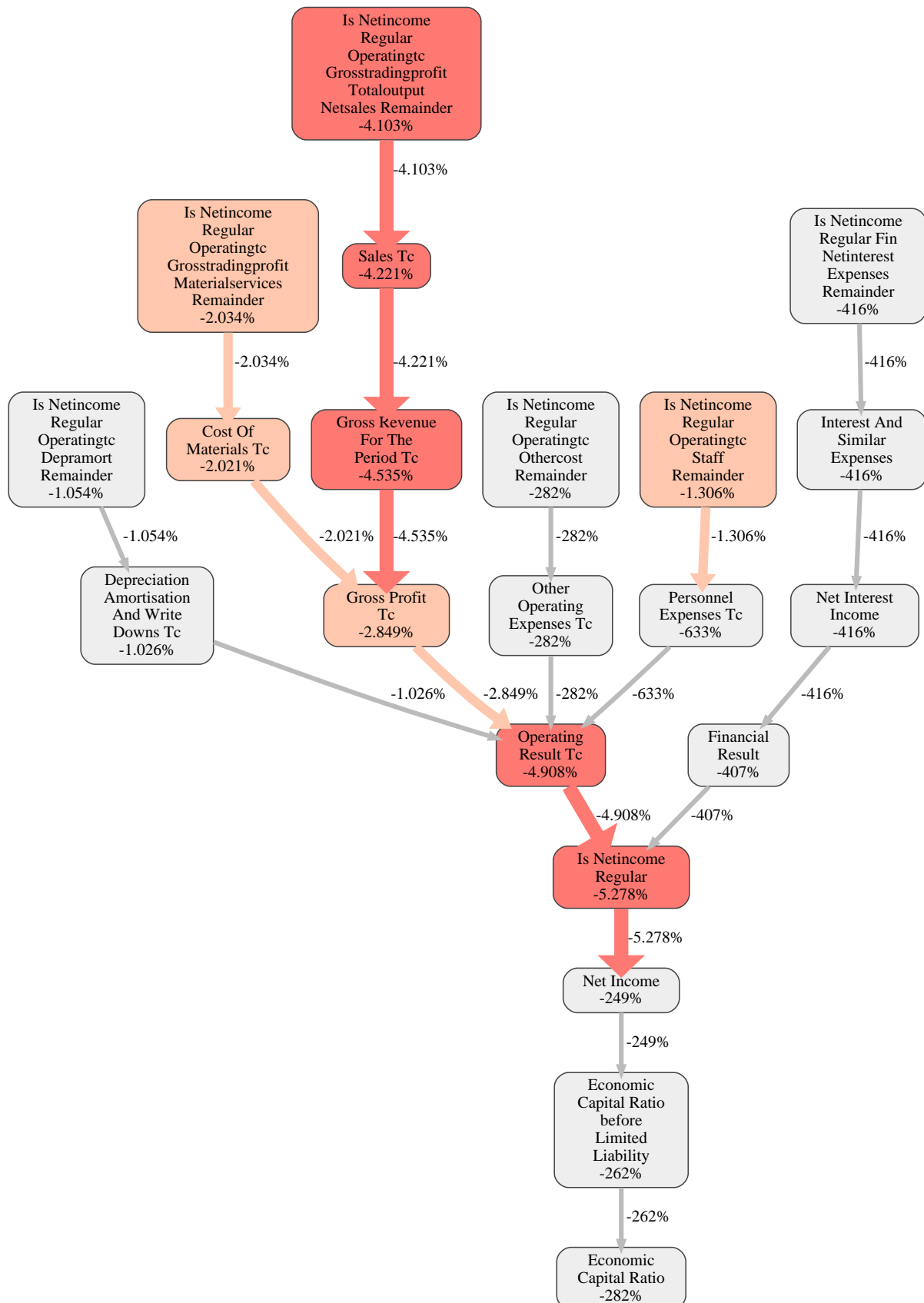

The greatest strength of Krüger Hochbau GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 80% points. The greatest weakness of Krüger Hochbau GmbH Co KG is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.278% points.

The company's Economic Capital Ratio, given in the ranking table, is 80%, being 282% points below the market average of 361%.
