



The relative strengths and weaknesses of Alzeyer Baugesellschaft mbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Alzeyer Baugesellschaft mbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 76% points. The greatest weakness of Alzeyer Baugesellschaft mbH Co KG is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.478% points.

The company's Economic Capital Ratio, given in the ranking table, is 76%, being 285% points below the market average of 361%.
