



The relative strengths and weaknesses of Josef Hebel GmbH Co KG Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Hebel GmbH Co KG Bauunternehmung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 108% points. The greatest weakness of Josef Hebel GmbH Co KG Bauunternehmung is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.536% points.

The company's Economic Capital Ratio, given in the ranking table, is 108%, being 253% points below the market average of 361%.
