

The greatest strength of Helmut Kallage Bauunternehmen GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 105% points. The greatest weakness of Helmut Kallage Bauunternehmen GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.468% points.

The company's Economic Capital Ratio, given in the ranking table, is 105%, being 257% points below the market average of 361%.
