



The relative strengths and weaknesses of Harfid GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Harfid GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 60% points. The greatest weakness of Harfid GmbH is the variable Work In Progress, reducing the Economic Capital Ratio by 7.809% points.

The company's Economic Capital Ratio, given in the ranking table, is 60%, being 301% points below the market average of 361%.
