



The relative strengths and weaknesses of B S Gesellschaft für Wohnungsbau Stadt und Dorferneuerung m are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of B S Gesellschaft für Wohnungsbau Stadt und Dorferneuerung m compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 83% points. The greatest weakness of B S Gesellschaft für Wohnungsbau Stadt und Dorferneuerung m is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.512% points.

The company's Economic Capital Ratio, given in the ranking table, is 83%, being 278% points below the market average of 361%.
