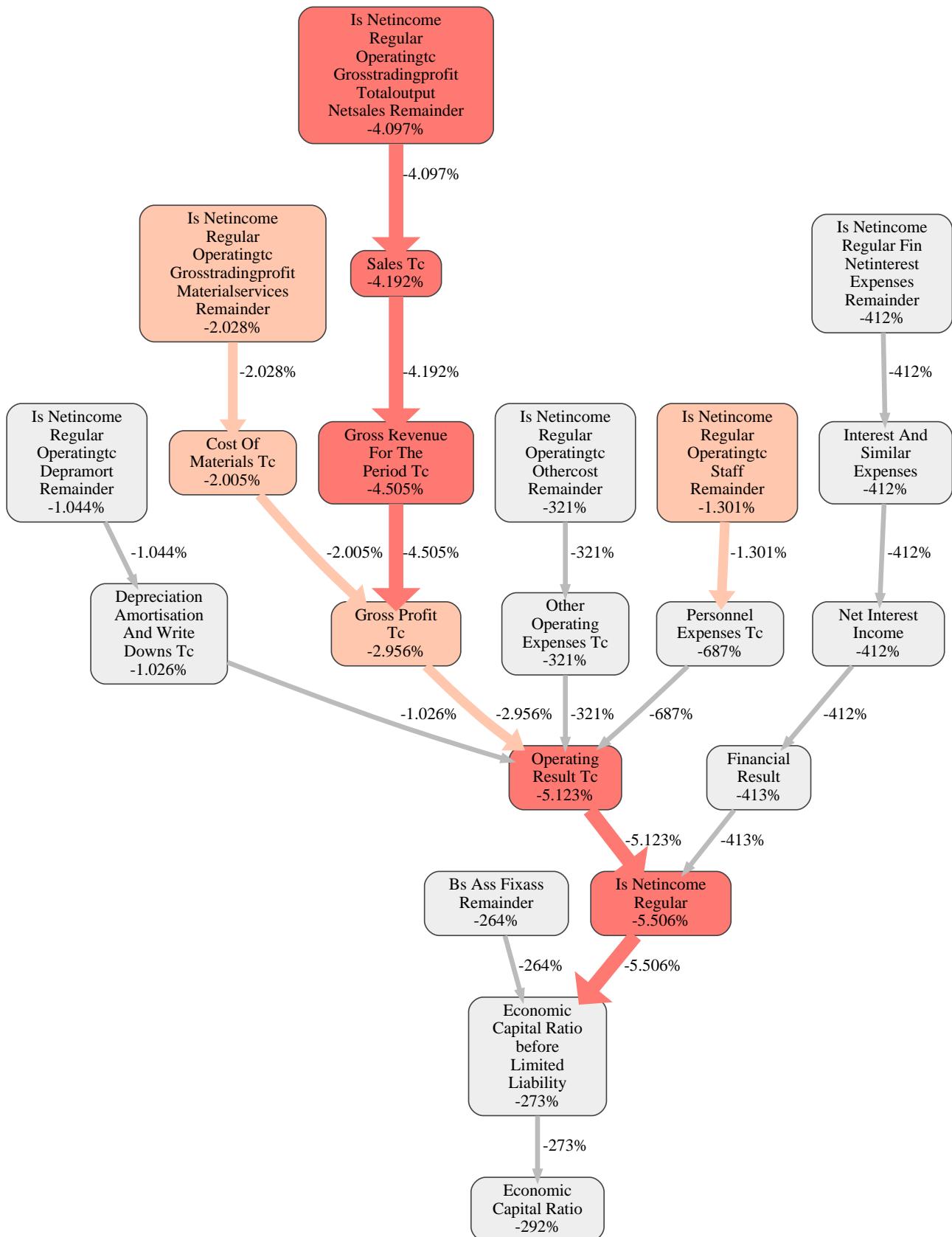

The relative strengths and weaknesses of Kreis Wohnungsbaugesellschaft Helmstedt mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kreis Wohnungsbaugesellschaft Helmstedt mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 69% points. The greatest weakness of Kreis Wohnungsbaugesellschaft Helmstedt mit Beschränkter Haftung is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.506% points.

The company's Economic Capital Ratio, given in the ranking table, is 69%, being 292% points below the market average of 361%.
