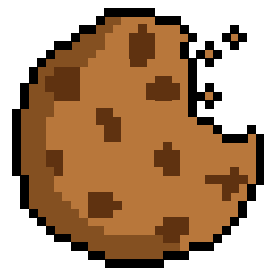

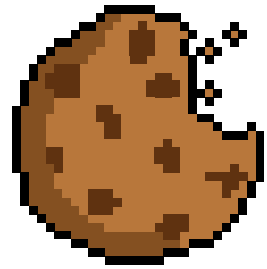
The greatest strength of Gesobau Wohnen GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 40% points. The greatest weakness of Gesobau Wohnen GmbH Co KG is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.488% points.

The company's Economic Capital Ratio, given in the ranking table, is 40%, being 321% points below the market average of 361%.

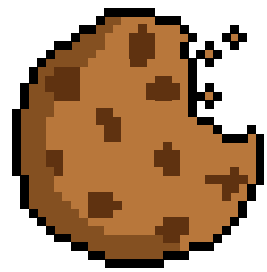
