



The relative strengths and weaknesses of Wohnungsbau und Verwaltungsgesellschaft mbH Luckau are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau und Verwaltungsgesellschaft mbH Luckau compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 79% points. The greatest weakness of Wohnungsbau und Verwaltungsgesellschaft mbH Luckau is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.445% points.

The company's Economic Capital Ratio, given in the ranking table, is 79%, being 282% points below the market average of 361%.
