



The relative strengths and weaknesses of Kommunale Immobilien Dresden GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kommunale Immobilien Dresden GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 150% points. The greatest weakness of Kommunale Immobilien Dresden GmbH Co KG is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.505% points.

The company's Economic Capital Ratio, given in the ranking table, is 150%, being 212% points below the market average of 361%.
