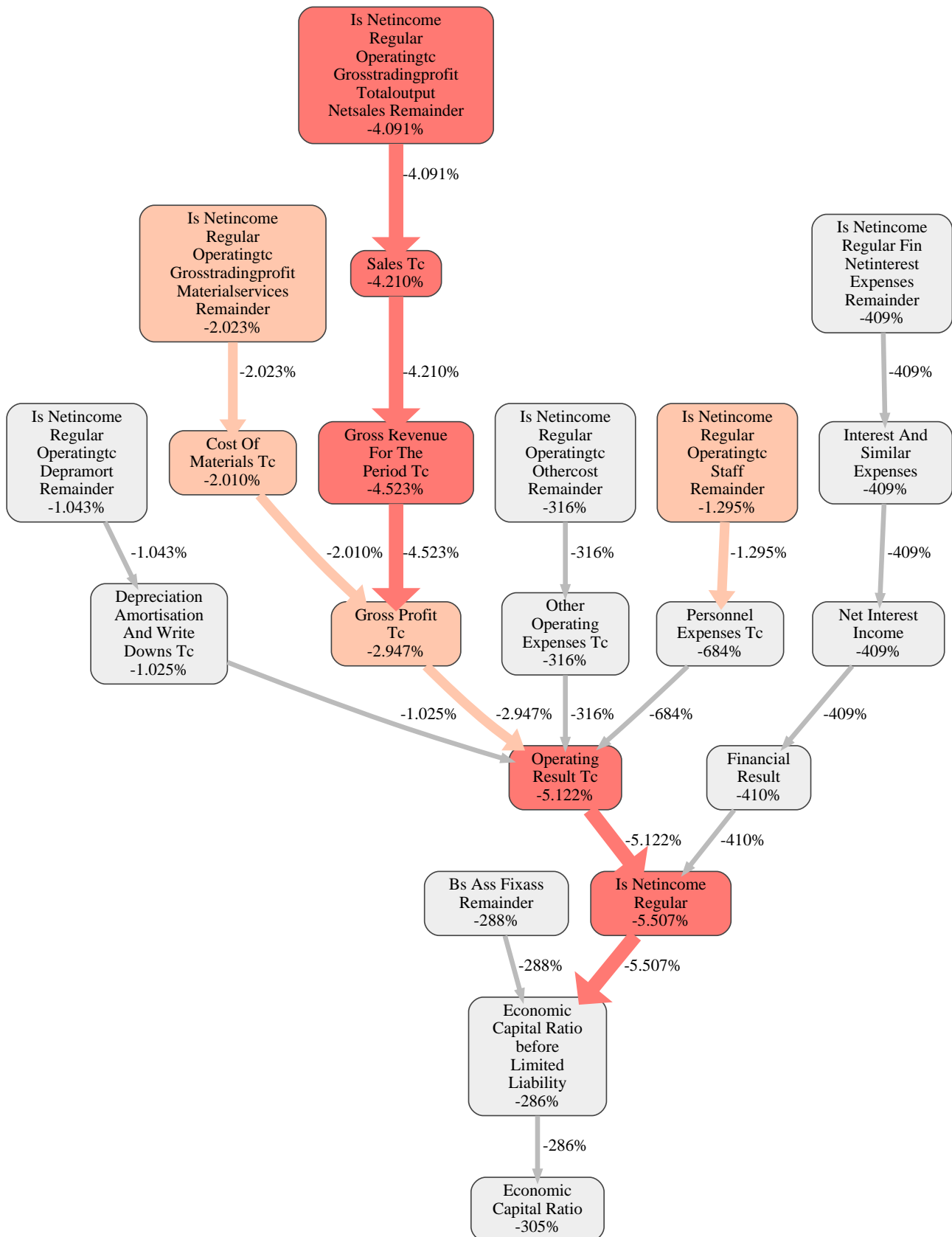

The greatest strength of Wohnungsbau Stadt Moers GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 56% points. The greatest weakness of Wohnungsbau Stadt Moers GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.507% points.

The company's Economic Capital Ratio, given in the ranking table, is 56%, being 305% points below the market average of 361%.
