The greatest strength of Wobra Wohnungsbaugesellschaft der Stadt Brandenburg an der Havel mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 130% points. The greatest weakness of Wobra Wohnungsbaugesellschaft der Stadt Brandenburg an der Havel mit Beschränkter Haftung is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.528% points.

The company's Economic Capital Ratio, given in the ranking table, is 130%, being 231% points below the market average of 361%.
